Sociology Department Holds Career Workshop

On April 16th the Sociology Department and the MOST Program held their semi-annual career workshop, "Careers in Sociology and Criminal Justice." There were several speakers present who touched on issues regarding interviews, resume writing, and other related information. Allyson Morgan, a '00 graduate of William Paterson, spoke about the various career opportunities available to graduating students in Sociology. She also highlighted some "do's and don'ts" of interviewing. The second speaker, Lynette Butler of the William Paterson University Police Department, discussed the benefits of getting involved with law enforcement. The keynote speaker, Dr. Roseanne Martorella, gave a brief lecture on constructing resumes. She emphasized the importance of having internships, especially when you do not have enough experience in other areas. There were also individuals from the Career Center present at the event.

While this workshop was geared towards students in the areas of sociology and criminal justice, students from other majors may have gained some valuable information from attending

the event. All the speakers emphasized that it is never too early to begin thinking about the future. Whether students are graduating this May or in 2005, they should begin preparation for their futures. They also made mention of doing internships over the course of a college career as some thing that can be advantageous. Another point shared by all was to formulate a resume no matter what your experience entails.

There were many other issues covered concerning resume writing and interviewing. Here are a few the Career Center points out: A resume should be no more than one page.

Its primary goal is to get you an interview, so you should highlight all your skills and experience.

Use action words when describing job functions.

Before you interview, do research on the company.

Take a trip there prior to the interview date, to know exactly where it is and how long it takes to get there. Do not arrive there more than 15 minutes early.

Dress conservatively.

MEISA Career Day

Over fifty students attended the Music and Entertainment Industry Student Association's (MEISA's) 2nd Annual Career Day on April 10th 2002. Like the previous year's event, the Career Day featured a panel discussion on various aspects of the music industry, followed by an informal networking session.

The panel discussion was moderated by Dr. Stephen Marcone who is head of the Music Management program at WPU and MEISA's advisor. After an introduction of statistics about the current state of the music industry, Dr. Marcone asked

the eleven member panel questions that pertained to their particular part of the music industry. Members of the panel included a music industry business manager, an entertainment attorney, the Vice President of sales of a record company, three representatives from Road Recovery (an organization that deals with addictions), two members of an independent public relations firm, a booking agent, a concert promoter, and a full service entertainment company. The panelists also provided information about how they personally got involved in the music industry and what a person who is looking to work in the industry can expect when looking for internships and jobs.

Paterson Mayoral Candidate On Campus

On April 18th I had the opportunity to interview Jose "Joey" Torres, a candidate for Mayor of Paterson. Torres is a three term councilman serving on the Paterson City Council; since 1990 he has chaired the City Council Community Development Committee and served on the Paterson Restoration Council. Torres has lobbied the city council to approve the revitalization plan and incorporate the HUD (Housing Unit Development) plan to get Federal money. For Paterson to be eligible for this money, they have to present a long term (five year) plan and a short term (one year) plan to rebuild the community. Through the creation of the Community Development Committee, Torres hopes to empower the community through education which will help get the city back on track. Torres believes in working



from within and wants to get down to the local level to revitalize the decaying neighborhoods.

Torres also hopes to bring the arts to Paterson; he has lobbied the council for a Request for Proposal for an area in downtown Paterson to build a 10,000 seat civic center that will help stimulate the economy.

Due to the fact that Paterson is the only city in the nation to have a double digit increase in crime, Torres plans to decentralize the police force and create individual neighborhood precincts. This will allow the city to look at crime stats and see where there is concern.

The neighborhood precincts will also allow for a quicker response time and help to combat the ever growing drug problem that Paterson faces. Torres feels that if the same police officer walks the same streets everyday, they will know exactly where the problems are. Lower crime rates will serve to spur the revitalization of the neighborhoods.

Mr. Torres wants to incorporate agreements with businesses for student job training. This will allow high school students a chance to work in the real world and better prepare them for the future. He also feels school facilities are under-utilized and that schools should be community centers, which would benefit the public immensely by providing important information. Torres feels that "information is power and that schools should be the clearing house for information."

After the panel discussions, the format of the program became more informal, and students were allowed to network with the individual panelists and ask questions that may not have been answered during the panel discussions. During the networking session I asked Walter Yetnikoff, a veteran of music industry who was attending the

event with Road Recovery, if he had had any regrets during his lengthy career in the music industry. He stated that he regretted being nasty to a lot of people, including his first wife, that he wasn't there much for his kids, that he got heavily into sex, drugs and rock-n-roll and something about a girl in Vancouver.

Overall, this event was a

great success and I would personally like to thank those who planned it for doing a great service for students at this university. Many students are perhaps already looking forward to next year's event which, like this Career Day, has proven to be bigger and better than those that came before it.





Campus Rally Held to Support State Funding of Colleges

On Tuesday, April 16, the Student Government Association (SGA) led by SGA President Rashad Davis organized a rally in Zanfino Plaza in front of the Student Center. The stated purpose of this rally was to show support for increased higher education funding from the State of New Jersey. This followed in the wake of a state budget cut and precedes expected tuition increases from the University.

This rally was organized as part of a series that are taking place on campuses across the state at the request of the New Jersey Higher Education Coalition of Students (NJHECS), an organization of Student Governments that represents the interests of students.

The rally consisted of a DJ

provided free of cost by Kingstone Entertainment followed by a speech by Davis, and concluded with a petition circulated through the crowd. While Davis and other Executive Officers in the SGA considered the rally to be a great success, and reported so to NJHECS, other students disagreed. Some thought that the rally seemed thrown together at the last minute, while others doubted that anyone was drawn who would not be in Zanfino Plaza for common hour anyway. However, Davis has provided evidence that at least one student was impacted by the rally, so it can be considered a success in that respect.

The rallies on other campuses have largely been pushed back by at least a week to allow for more time to plan. As such, there is no information available on the successes there yet.

A Look at the SGA

After a year of preparation and a final six hour long meeting, the SGA Court of Judicial Review has at last completed their revisions of the SGA Constitution and By-laws. The new document, when passed, will be the permanent Constitution of the SGA, as opposed to the current system under which the CJR reviews the constitution annually and changes things around. In this way, we can hope to eliminate the inconsistencies that arise over the years as sections are changed without cross-referencing the entire document. Because the CJR Meeting was so long, quorum was lost before the Constitution was finished. As such, CJR Chair Mauricio Mattos, who spearheaded the herculean effort of repairing the flawed document, will solicit the votes of the members of CJR in writing before the Legislature Meeting, where it will [hopefully] be approved by two-thirds [2/3] of both the Legislature and Executive Board. If passed (and the document must go to the Legislature twice to do so), the new Constitution will take effect on June 1 of this year.

The SGA Awards Committee will soon begin reviewing the nominees for award recipients. SGA Executive Vice President Daren Smith, who chairs the committee, has already sent out notices to people nominated. Those who are being considered for an award must turn in an information packet detailing their activities and qualifications.

Nominations for SGA Elections will close this Wednesday, April 24. The elections themselves will take place on the Tuesday and Wednesday of Springfest in the Student Center. Students interested in running for a position must go up to the SGA Office before nominations close and fill out the proper form. All students are encouraged to vote in the election.





Lou Poandl, the director of facilities management, he explained the lengthy procedure that campus facilities goes through to change the systems from heat to A/C. He explained it takes two-three weeks to change the systems over. He also stated that he met with President Speert on Wednesday April 17th, and they both reaffirmed that changing over the dorm systems are their top priorities. If this were the top priority, however, facilities management would've

taken advantage of the unseasonably warm winter and the change over would've taken place sooner.

It's bad enough most rooms in the apartments have not had cable all year and file sharing on the internet is banned all over campus, but now residents have the added pleasure of being able to roast in their rooms! Still unhappy with the conditions? Want to take a stand? Not only should all residents call the president's office and tell them that you're unhappy, but also call all the local newspapers and most importantly call the Township of Wayne Department of Health. Tell them about the lack of air conditioning, tell them about the barred windows. Maybe if there is enough outside pressure then this school will finally begin change. Nothing like bad press to wake up an administration that outright ignores the students.




Hey Unsure,

The Veiled - The Nun - The Ninja - The Hijab (and its Concealed Truth)

I write this article, as previous articles and as those to come, in the name of God, the Most Beneficial, the Most Forgiving, Salaam to all.

Now why is it that Muslims tend to begin doing anything "in the name of God?" I've often heard Muslims say "Bismillah!" instead of laughing or saying "oops!" when a person falls. Before eating, before switching on a light, or before opening up an email, "Bismillah." I'm sure that when Islam was first revealed (which would be from the time of Adam because even he professed faith in one God) there were no computers so why do Muslims today turn on their computers in the name of God? The simple answer is that any faithful person would recognize that God exists at all times and due to His mercy we have such things as food, electricity, and the Internet. And so we come back to the beginning where the meaning of Islam, which would be surrendering oneself to Allah, comes into play.

As I've discussed earlier in the semester, Muslims' foundations are the Quran and Sunnah. The Holy Book and the practices of the Prophet (Peace be upon him). Since the Prophet did not eat rotten food, Muslims don't eat it either. Some may argue that throwing food away is a waste, but it is really harmful to the body. The Quran says not to eat anything from a pig or an animal that hasn't been sacrificed in the Islamic manner, so Muslims don't

eat ham, bacon, Starburst, Skittles, and Poptarts with gelatin.

So, when in the Quran it states: "Say to the believing man that they should lower their gaze and guard their modesty; that will make for greater purity for them; and Allah is well acquainted with all that they do... And say to the believing women that they should lower their gaze and guard their modesty; that they should not display their beauty and adornments except what (must ordinarily) appear thereof; that they should draw their veils over their bosoms and not display their beauty except to their husbands, their fathers... (a list of exceptions)" [24: 30-31] and "O Prophet, tell thy wives and daughters and the believing women that they should put on their outer garments; that is most convenient in order that they may be recognized" [33: 59].

And when the Prophet (PBUH) said to Asmaa (the daughter of Abu Bakr):

"O Asmaa! When a girl reaches the menstrual age, it is not proper that anything should remain exposed except this and this." He pointed to the face and hands (Abu Dawood).

Then the title of the documentary that the MSA showed on Thursday April 11, 2002, Hijab: An Act of Faith, is accurate. Obviously when Allah's words are to cover oneself, then it becomes mandatory for Muslims to dress correctly. In today's

world this dress, also referred to as hijab (Arabic for concealed or veiled) is misconceived. The hijab is used to keep women isolated. Women that wear it are being oppressed. They've been brainwashed. False, wrong, incorrect. No, no, no, no, no.

The documentary covered these stereotypes that women face as converts, college students, and workers that begin to observe the Islamic dress. They spoke about not having to waste time in the morning with make-up and clothing and didn't have to worry about how people would look at them. (In high school I'd be surprised when people I knew would wake up at six to "get ready" for school and not take out five minutes to pray the morning prayer.) Two members of the MSA, Nazek Habatfha and Nagwa Elsamra shared their experiences in wearing the hijab. Nagwa began wearing it when she was in fifth grade and as she began to understand it, she also began to see the misunderstandings of it. Nazek, who recently began to wear it, feels closer to Allah and Islam. They've both stated that wearing it is not the only thing, but also "the way people present themselves and conduct themselves" that is part of being modest.

In Islam, women are given the same honor, respect, and progress as men. They aren't prevented from driving, working, or voting. They aren't used to sell clothes and cars. Now, I'm sure a piece of

cloth on a woman's head does not automatically limit her skills and intelligence. On the first day that a woman decides to wear hijab she forgets how to speak and write in English! Rather, it's the law and individual people's thinking that sets these limits and stereotypes. The hijab, like the beard and turban, have attained unpopular connotations.

This "negative baggage" has caused hesitation and contempt towards wearing hijab. Many women begin in stages (i.e. stop going to mixed parties, don't look at people of opposite gender, begin wearing a scarf at events...). This does not mean that they are not strong enough. Nagwa grew up with it and understood it later; Nazek understood Islam thoroughly and then began to wear it. Regardless, both of them have always been practicing and learning Muslims. Religion is not compulsory. As Nazek said, it's "obnoxious and discouraging" when people tell you that you have to wear the hijab.

From several references (as stated above) scholars have concluded what the minimum requirements for hijab are:

1. Clothing must cover the entire body with exception for the face and hands.
2. The attire should not be form fitting, sheer, or eye-catching.
3. Clothing must not suggest fame or status.
4. Clothing should not resemble that of the opposite sex.


Similar requirements are for the

men in that they must always be covered from navel to the knees and should not wear tight, sheer, or revealing clothes, or that of the opposite sex. They are also not allowed to wear silk, which may include ties (except for medical purposes).

Most importantly, in the Quran it is stated: "On no soul does Allah place a burden greater than it can bear" [2:286]. Muslims' lives are centralized around praying to Allah (which I'll discuss another time) and trying to attain a place in Heaven. Therefore, everything a Muslim does is for the Hereafter and should not be converted into something materialistic. Leading such a life is easiest when a person understands the concepts of religion. Who's to be feared? The government and people passing by, or Allah? So people shouldn't do things, like wearing hijab, to show anyone that they're good Muslims; rather they should do it because Allah says to, and they can trust that Allah hasn't ordered them to go beyond their limits. With time everyone will understand and accept hijab and see the strength of Muslim women. In addition, next semester a new course will be offered through the women's department about women in Islam (WS 399).



This past Friday and Saturday (April 5th and 6th,) in Harrisonburg, VA, was the annual Macroock Music Festival and Conference, one of the biggest yearly gatherings in Indie Rock/Hardcore/Punk music. The lineup for this year's Fest was incomparable with such legendary/well-known bands as **Fugazi, Avail, Rainer Maria, Ted Leo and the Pharmacists, Zero Zero, and the Dismemberment Plan** headlining the many shows that were scheduled all over the James Madison University campus and other Harrisonburg hot-spots.

My journey to good ol' Harrisonburg began with my waking up at 7:30 am on Friday morning to be ready for my friend Rachel and her friend Adrienne to pick me up at eight. Already things weren't going quite as planned, and they kept me waiting for over two hours watching my girlfriend sleep and wishing that I could also still be sleeping. Finally they arrived at my place at 10:45, and after a stop for coffee and a Discman car-adaptor, we were off. We were hoping

to get to Harrisonburg as early as possible so that we could catch some of the early bands which would be starting at around 5:00 pm.

Despite our late start time, the ride went smoothly and quickly, as we jetted through Pennsylvania, Maryland, and West Virginia, and arrived in VA with time to spare. We checked into the conference and looked around, then went to an amazingly-cute, little, vegetarian joint in Harrisonburg called The Little Grill. While we were at the Little Grill we sat down with the Macroock schedules and planned out our weekend. With Macroock, planning is extra important because shows are set up all over Harrisonburg and they all coincide with each other, so you must be vig-

ilant and mobile in order to see as many bands as possible. Inevitably, you will miss some bands that you would have liked to see, but if you play your cards right, as we did, your Macroock experience can be a great one.

To start off Friday night, we headed over to the PC Ballroom on the JMU campus, where we spent most of the evening. The show taking place at the PC Ballroom was labeled the Lovitt Records Showcase, and although many of the bands are from

Lovitt, there were also some great non-Lovitt bands on the bill as well. We looked around for some time and eventually settled in to witness a riveting set from Tigerstyle Records' **The Mercury Program**. The band dazzled the growing crowd with their quirky instrumentals and impressed many of us with their tasteful use of the Vibraphone. A little jazz-fusion, a little rock, The Mercury Program provided a great starting point for a great Fest.

New Lovitt band **Dame Fate** was up next, although their set was not memorable. From what I can recall, the all-female band often looked like they were about to kick out the jams at any moment but never did, instead settling into slow-tempo rock which bored many in the audience. After taking a brief respite to check out the activities at the Godwin Gymnasium, where a harder showcase featuring such bands as **Poison the**

Well, Darkest Hour, Hopesfall, and Crutch were playing, we were disappointed to find out that the only band on that bill that we wanted to see, **American Nightmare**, canceled due to unspecified injury.

We got back to the PC

Ballroom in time to catch stellar sets by both **Fin Fang Foom** and **Bats and Mice** (ex **Sleepytime Trio** and **Four Hundred Years**.)

Both Lovitt bands rocked the crowd and kept the energy on full blast. Next up was one of the biggest surprise bands (for me at least,) **Denali**. Unfamiliar with their sound (although Rachel warned me they were incredible,) I was prepared for whatever they had to throw at me. What they had was a beautifully crisp performance, focusing on the singing and song-writing of leader Maura Davis. A side project of **Engine Down** members Keeley Davis and Jonathan Fuller, **Denali** blew away the audience with their **Portishead**-like sound. The band's merch table was rushed after their set, as the band proceeded to sell out of their debut LP, more than a full week before it's release.

Soon after **Denali's** set, we headed over to the Court Square Theater, which was by far the most comfortable of the Macroock venues, to catch **Matt Pond PA**.

The Court Square would house the more low-key acts for the weekend, which was appropriate with it's playhouse atmosphere. Some of the acts playing the Court Square on Friday were **Kyle Fischer** (of **Rainer Maria** fame,) **Canyon**, **Mighty Flashlight**, and the **Princeton Reverbs Council**. **Matt Pond PA** played to a small yet attentive crowd and did what they always do. Which is to rock out, in a mellow way, showcasing many songs off of their newest LP the **Green Fury** (Polyvinyl Records.) After the band's impressive set, we stopped at their swamped merch table before heading back to the PC Ballroom just in time to catch an Amazing set by VA's own **Engine Down**. In the intervening time, **Rah Bras and Q** and **Not U** had impressed the now crowded Ballroom.

Engine Down took the stage at around ten to midnight and proceeded to rock their hometown crowd for 45 minutes. Their set was very high energy, as they played mid-high tempo indie rock like nobody's business. Their rhythms were tight and right on point and the band played songs from all of their

albums, including the newly released **Demure**. After **Engine Down's** captivating set, the stage was set for the day one head-



liner, the **Dismemberment Plan**. **D. Plan** played to a packed house, and art-funked their way through over an hour of material, including favorites off of **Change**, **Emergency and I**, and the **Dismemberment Plan is Terrified**.

After **D. Plan's** rock was done, we drove around and contemplated the sleeping situation, and eventually decided to just crash in the car, due to the lack of funds that Rachel and Adrienne seemed to be feeling. Cut to Saturday morning—

After Zero Zero, we spent most of the rest of the day at the Polyvinyl Showcase at 20 N. Main St. At this indie rock-spectacular show, fans were treated to sets from such indie greats as Rainer Maria, Ted Leo and the Pharmacists, Karate, The Ivory Coast, Aloha, and the Party of Helicopters. From Atlanta through America, Injected Rise Above the Rest

Injected are everywhere these days. Whether you flip open an industry magazine or turn on the radio, chances are you'll encounter them. It's all because of the video for their hit song, "Faithless," and it's catchy hook, "I'll never be cruel and I'll always play the fool to be as loveless, as shameless as you."

The song is the lead single off their major label debut, *Burn it Black*, on Island Records. It's launched them into the spotlight via a tour with Nickelback and Default for MTV's Campus Invasion and got them recognized by *Alternative Press* magazine as a band you need to know. So who exactly are Injected?

Danny Grady is the vocalist and founder of the band. Ironically, he originally started it as a metal band, but changed genres because "It became too self-indulgent." It was a move made for the better, because judging by the hidden track, sticking with metal would not have gotten them anywhere.

Paired with his long time friends, Jade Lemons (guitar), Steve Slovisky (bass) and Chris Wojtal (drums) Grady has succeeded with making music that is straight up rock. The Atlanta based band feels their location has helped them to rise above the rest of the aspiring bands in the world. Says Lemons of Atlanta, "Since it doesn't have the music industry presence of New York City or Los Angeles, the pressure to be the next greatest thing isn't so high."

It was when they were playing a pressure free show that fate walked backstage, in the form of Butch Walker. The vocalist of one of the most underrated and now defunct bands, *Marvelous 3*, had seen them perform and took an interest in them. He approached the band and they asked him to produce their record soon after. "He's a pop guy and I'm a metal guy and we each pulled in opposite directions. We knew we'd wind up landing somewhere in the middle and it turned out great," says Grady.

The result was vocals that at times were reminiscent of Silverchair, at others of Soundgarden, and music that is often dark, but nonetheless appealing. "Faithless" is the most pop influenced song on the album. It opens strong with "When She Comes," and then goes deeper than orgasms and into alcohol addiction ("Only Hurts a While") and themes of being paralyzed by depression ("Ms. Fortune"). They were songs written as gifts to friends of the band who faced these issues. As for more world wide issues, they penned "Bullet," a song about the violence in schools.

The lyrics are standout elements that add to the moods of the tracks. On "Only Hurts a While," when Grady sings "I've poisoned my dreams with a feeling that seems to leave me all alone." Later on, with "Bloodstained," he pours out, "because I haven't felt pain in so long I forgot I was alive." The closing track, "Dawn," culminates all the elements of the CD and makes for a stellar track. The vocals are powerful and the mood shifts back and forth between dark and light, heavy and upbeat.

The secret for their success lies behind one idea. Grady says, "You have to remember that at the end of the day, it's not about making your band the heaviest, or the most rebellious, or having a token bald guy in your group. It's about art, and making something that will last long after you are dead."





ROCK CANDY: SUGAR CULT

Infectious pop rock is represented at its best on **Sugarcult's** major label debut, *Start Static*. Every song has a catchy hook, whether it be the lyrics or the vocal style of Tim Pagnotta that draw the listener in. The album is an eleven track joy ride that takes you into a momentary world of song.



Every song tells a story, with themes ranging from living in a boring town in "Stuck In America" to being devastated over seeing your ex with someone new and then finding someone new yourself in "How Does It Feel." The songs are short and to the point, so every lyric, every drum beat and every stroke of the guitar chord is significant. All the elements together make for an addictive CD that you'll crave listening to.

Sugarcult make even the saddest of topics enjoyable to listen to. Lyrics on "Daddy's Little

Defect" are "So don't make a sound / Your father's around to play with your head/The gift-wrapped guilt trip kisses left you naked in your bed," but come across almost therapeutic for someone who suffered through such a thing and tells them it's OK to let go. The pace slows on "Crashing Down," which sets a somewhat somber mood for telling the tale of a relationship that is withering away. The chorus on "Saying Good-bye" ("She's saying good-bye and leaving tonight/She's wasted all her lonely teardrops now") makes sad sound so good.

The best parts, though are the in your face odes to love. "Pretty Girl (The Way)" is one of the best songs on the album. After listening to it, the chorus (It's the way that he makes you cry/It's the way that he's in your mind/It's the way that he makes you fall in love) becomes implanted in your mind. "Lost in You" ends with a punch line: "I almost forgot your face till they played that song tonight, the one we used to hate." There's even some realistic humor, like on "You're the One," which goes, "I'm in love but it's only temporary."

Family Struggles Abound in Topdog/Underdog

Topdog/Underdog, a Pulitzer-Prize winning play written by Suzan-Lori Parks, began its Broadway run on April 7th at the Ambassador Theatre in New York. *Topdog/Underdog* is a tale of two brothers, played by hip-hop artist-turned-actor Mos Def and Tony Award winner Jeffrey Wright, of *Basquiat*, *Boycott*, and *Bring in 'Da Noise, Bring in 'Da Funk* fame. The two brothers names, Booth (Def) and Lincoln (Wright) is the first significant facet of

Topdog/Underdog's plot line, which explores the roles of family members in dire situations. The entirety of *Topdog* takes place in Booth's inner-city apartment, and the two brothers are the only characters in the play. Parks was inspired to write *Topdog/Underdog* by two things: first, she made changes to a character she had initially introduced in her 1992 play *The American Play*. This character was a black man whose occupation was to play Abraham Lincoln in an arcade, where he would routinely be "shot" by tourists who were playing the part of John-Wilkes Booth, Lincoln's assassin. Parks decided to rework this character and actually name him Lincoln and create an even odder scenario by naming his younger brother Booth.



Now, with these names and an animated relationship which revolves around the street-smart world of shoplifting and 3-card monte in tow, Parks moves on to create a play which is at the same time both hilarious and sad. A lot of fair predictions of *Topdog/Underdog's* plot could be made and some turn out to come true but the importance of the work doesn't lie in it's mystery. The importance of *Topdog/Underdog* instead is found in its exploration of the

family dynamic created when two brothers are abandoned by their parents and have only each other to rely on. Lincoln's calm reassurance, combined with Booth's wild, egotistical, behavior present the two characters with the dilemma of how they can "make it" in the world. Inevitably, both turn to vices, such as drinking and lying, to escape the harsh reality they face on an everyday basis. Following the brothers throughout the story, Lincoln's struggles trying to free himself from the dangerous world of card-hustling adds another dimension of sincerity to their plight. The story winds all of these elements together smoothly, utilizing well-timed comic relief to cushion the pain, and brings the whole plot to a heated ending, one which should create discussion amongst audience members.

As far as the performances go, Mos Def turns in a good showing, and makes it seem that with a few more shows under his belt, he will be able to hold his own on a Broadway stage. While Def does a good job, Wright definitely steals the show. With all the emotion and facial expressions of a great actor, Wright certainly shows why he is a Tony-Award winner. His performance makes the entire story plausible, showcasing both his talent for dialogue and monologue, as he is alone on stage for much of the



play. *Topdog/Underdog* is absolutely a must-see for fans of either actor, and a lot of the hipster set in general. If the star-spotting in the audience was any indication (Macy Gray, Judd Hirsch, and Eric Bogosian were all in attendance at this particular performance), then *Topdog/Underdog* will remain a hot Broadway ticket for quite some time.


"PAINTERS" AT WPU

"Painters", a graduate/undergraduate art exhibition, is currently being held in the Power Art Building off of

Hamburg Turnpike until May 3rd. Why the simple introduction? Simple. "Painters" is a simple strait-forward art show. No glitz or flashy lights in this show. It's just you, the artwork, and the wall. In a way this is a positive aspect, there is not the overload and compaction you see at many art exhibitions. The collection of work is small, with only eight artists "I wanted the space airy, lots of space so the art can breathe", says Lillian Prince, curator of the show. A WPU Art Professor, Lillian Prince describes the reasons for this show as being, "most students don't have a chance to meet other artists from other schools and see what other art is going on". "I wanted to choose schools as well that were on par with what WPU is producing to meet each other" Prince added. The three schools that comprise the show, WPU, Pratt, and SUNY-New Paltz had facility submit student pieces of work to Prince in which she chose the images to be presented. In her criteria for selecting the artwork Prince said, "I wanted to find combinations of subject matter and surface, abstract and figurative".

The presentation of the work though is where things fall apart a little bit. A few of the pieces in the show are rather raggedly displayed in an unprofessional fashion. Despite these flaws though, there are things to be seen here. The majority of the work in this show is rather impressive, despite the unattractive presentation. The work of Dave Matheson, a WPU student, and Kris Headly show imaginative use and mix-

tures of medium to produce sharp visual effects. Andrea Gellar Jablonski, also a WPU student, produces a strong effort of her own with her abstracted landscapes. The one dimensional work of Cynthia Levine's "8 guardians", and Joe Levicka's strait forward portraits do not rival the strength of the other exhibited work and unfortunately remain easily forgettable.

A victim of the aforementioned presentation problem, Bryn McConnell's "Untitled" and "Valentines" still retain elements of interest. McConnell's work, "Untitled" is

mostly decorative in sensibility, the swatches of different faces within the frame of the composition morph each other into a quilt-like pattern. "Untitled" overall has a "classroom like" feel to it as if it was being done for a class.

"Valentines", the stronger of McConnell's work in this show uses the same method of pattering but produces stronger psychological reaction. "Valentine's" is pleasantly disturbing, portraits of a marginal woman on the edge of herself. This work examines the idea of the valentine and

what is true beauty. The figure within the work is the "anti-valentine", pictures of a woman dispossessed


and alone, disturbed, without love, and hopeless. Andrea Gellar Jablonski's landscapes across the floor form these provide a change of pace. Jablonski, a MFA student here at WPU paints her landscapes in a series and abstractly. These attractive works are done very small, no larger than 12 inches in diameter in most cases but are intimate for the viewer. Jablonski uses a synthesis of visual vocabularies; one can tell this artist is aware of the artwork of Cezanne and abstractionist Franz Kline in the way she constructs her compositions. Even though the renditions of nature are violently abstract, the viewer receives a sense of calm and the organic flow of the landscape in these pictures. Jablonski's muted, controlled, earthly palette adds to this calmness. Jablonski also adds a cerebral element to her work as she gouges holes in the surface of her paintings. By doing this to her paintings, Jablonski achieves a complete rejection of the reality of the painting surface. These holes represent the personal beauty aesthetic of the artist. Without doubt he strongest work within the show is the work of WPU art student Dave Matheson. Matheson's "rust paintings" dominate the gallery space. The work is a mixture of definitive imagination and maybe a little of veiled pessimism. Matheson presents rust, an eternal modern image of decay as beauty, and dives into a unique examination of the painting surface. Matheson in a sense is metaphorically destroying the surface of the traditional visage of painting in these works. He uses a unique and personal vocabulary to display disgust with the traditional painting picture and art. Regardless of any explanations though Matheson's paintings are simply cool to look at.

Books' recent release by Ben Marcus is definitely a piece of work. One of the many things that occurred to me as I read was that it takes talent to make what seem like random paragraphs about strange topics fit together into a coherent story as Ben Marcus was able to do with remarkable success.

I need to clarify a couple of things before I start. The main character in the book is Ben Marcus. It isn't, however, the same Ben Marcus that wrote the book. The only connection is the same name. I will refer to the character from now on as Ben and the author as Marcus. That might help.

My favorite chapter in the book, which also happened to be the first in the book, is an introduction/rant by Ben's father. I almost fell off the couch up here in the office when I read that. It sounds like something George Carlin would say. Maybe I'm wrong, but I still thought it was really funny.

The book in general is funny. Some of the things that happen to Ben and what he says had me sitting there scratching my head and wondering if he meant what I think he meant. There was an incident with Ben and his dog. There is also little more than a page about how Ben thinks everything should give more sexual pleasure,

including the characters in books that we should be able to fondle.

All in all, if you're up for a little strange reading that will have you laughing more than a few times. The book is definitely a good choice. If some of the stuff goes over your head as I definitely think it did for me, it doesn't matter. There's enough in there to enjoy to cancel out whatever you might not get.

Individual weaknesses in softball: I need to get my legs stronger as a result of knee surgery. I also need to work on hitting mechanics.


