The Hobart Manor House, a national historic site built in 1877, is located on the campus of William Paterson College. The college is presently engaged in the renovation of the manor and in conjunction with this activity is conducting historical research regarding the Hobart Family.

The Hobarts were a prominent New Jersey family, philanthropic and political leaders of the nineteenth century. Garret Hobart served as Speaker of the New Jersey Assembly and President of the New Jersey State Senate before becoming Vice President of the United States under McKinley.

It is the intention of William Paterson College to organize an exhibition and to produce an accompanying catalog of the Hobart Art Collection and related memorabilia. We are seeking funds from the New Jersey Historical Commission for the restoration of these historic artifacts so they may be presented and documented as an important part of New Jersey's history.
