The meeting was called to order at approximately 9:15 a.m. in the College Hall Board Room.

MINUTES OF THE OCTOBER 11, 2003 BOARD MEETING:

The minutes of the October 11, 2003 Board meeting were approved as distributed.

CHAIR'S REPORT:

Fred Gruel, Vice Chair announced that Mr. Michael L. Jackson, has been approved by the Governor and State Senate for appointment to our University Board. Mr. Jackson owns a computer consulting firm based in Newark and is a resident of Randolph. He will be sworn in at the February Board meeting.

PRESIDENT'S REPORT:

1. The President reported that the annual Thanksgiving Dinner for Seniors was a huge success. The program was brought to William Paterson by Dr. Sesay. This year, almost 400 seniors were served from over 40 community groups. About 130 area businesses contributed goods and services for the event. Entertainment was provided by the William Paterson Gospel Choir, professional dancers Robert Sweeney and Rebecca Reid, and the Wayne Senior Swing Band. Every senior was given a gift basket donated by the University community or student clubs. One hundred fifty volunteer staff and students were on hand to decorate, set-up, serve and clean up. Lifetime Achievement Awards were given to seven area seniors and Della Crews, reporter and anchor from News 12 New Jersey served as emcee.

- 2. Dr. Speert reported that there was a ribbon cutting ceremony for the Russ Berrie Institute Sales Laboratory on December 12. This lab is unique in the university setting and is supported by \$4 million gift from the Russ Berrie Foundation. It, combined with the E*Trade Financial Learning Center, on which Professor Haiyang Chen will provide a report, greatly enhances the Cotsakos College of Business.
- 3. The President reported on the tabling of the restructuring plan for Rutgers/NJIT/UMDNJ. The decision raises concerns for William Paterson and other universities on the fate of the bond issue for capital projects. Of a possible \$3 billion bond issue, state universities were hoping for \$1.5 billion for their capital projects.

<u>Presentation by Professor Haiyang Chen, Director of E*Trade Financial Learning Center</u>

Professor Chen provided an overview of the accomplishments and plans for the E*Trade Financial Learning Center. He reviewed the Center's comprehensive five-year plan and described two major programs held – A "Student Investment Trading Challenge" and Summer Boot Camp – "Money and Investing" for high school students.

The Board gratefully acknowledged the efforts of Professor Chen and the staff in providing such a state-of-the-art center and useful programs for our students and the surrounding community.

Whereas: The Board of Trustees (the "Board") of William Paterson University of New Jersey

(the "Public College") desires to approve the construction of two new residence halls to increase the Public College's housing capacity by approximately 372 beds, as well as the related redirection and realignment of the road providing suitable access to the new residence halls (collectively referred to herein as the "Project"); as presented and submitted in the Public College's Facilities Master Plan under

date of July 2003 (the "Master Plan"); and

Whereas: The Public College has determined that the Project will assist in serving the needs

of its students and in the operation of the Public College; and

Whereas: The Board of the Public College desires to approve the cost of the Project in an

amount not to exceed \$29,000,000; excluding all related financing costs; and

Whereas: The Public College has further determined that the financing for the Project should

be accomplished by the issuance of tax-exempt and/or taxable bonds of the New Jersey Educational Facilities Authority (the "Authority"), through a fixed rate financing structure to be secured by a lease and agreement and desires to authorize the officers of the Public College to take all action necessary to

accomplish the financing of the Project and all related financing costs; and

Whereas: The Board of the Public College is authorized to convey or cause to be conveyed

to the Authority a certain parcel of land on the Public College campus upon which

the Project is to be located; and

Now, therefore, be it resolved by the Board of Trustees of William Paterson University of New Jersey as follows:

Section 1. The Board hereby approves the Project as presented in the Master Plan in an

amount not to exceed \$29,000,000; excluding all related financing costs.

Section 2. In order to finance the Project and all related financing costs, the Board hereby

authorizes the Public College to enter into a Supplemented and Restated Lease Agreement between the Authority and the Board of the Public College (the "Agreement") and such Agreement shall secure repayment of the bonds to be issued by the Authority to finance the Project and all related financing costs.

- Section 3. The Agreement, with such changes, omissions, insertions and revisions as shall be approved by the Authority and the authorized officers of the Public College as herein defined is hereby approved. The Chairperson, the Secretary of the Board, the President and the Vice President of Administration and Finance (the "Authorized Officers") are hereby authorized and directed to execute the Agreement in the name of and on behalf of the Board of the Public College, in as many counterparts as may be necessary, and to affix or impress the official seal of the Public College thereon and to attest the same. Such execution and attestation to be conclusive evidence of the approval of the form and content of such Agreement.
- Section 4. The Authorized Officers of the Public College are hereby authorized and directed to execute, deliver and approve any and all such other agreements, documents, certificates, directions and notices and to do and perform such acts and to take such actions as may be necessary or required or which the Authority may deem to be appropriate to implement the purposes of this resolution, to consummate the Project and the financing of the Project and all the costs related thereto by the Authority, and to effectuate the execution and delivery of the Agreement, and any other documentation necessary to effectuate the Project or the financing of the Project by the Authority. Any Authorized Officer of the Public College is hereby authorized and directed, for and on behalf of and in the name of the Public College to attest and deliver said documentation and to affix the seal of the Public College to said documentation. Such execution and attestation to be conclusive evidence of the approval of the form and content of such documentation.
- Section 5. The Authorized Officers of the Public College are hereby authorized and directed to execute any documents and take any action that may be necessary for the conveyance of that certain parcel of land at the Public College for which the Project is to be located.
- Section 6. The Board of the Public College hereby ratifies the submission to the legislature for the financing of the non-revenue portion of the Project as previously presented in the Master Plan.
- Section 7. All resolutions, orders and other actions of the Public College in conflict with the provisions of this resolution to the extent of such conflict are hereby superseded, repealed or revoked.
- Section 8. This Resolution shall take effect immediately.
