This collection of William Paterson papers was purchased by the William Paterson College Alumni Association and donated to the College. Part of the estate of Edward J. Grassman of Elizabeth, New Jersey, the collection was obtained at auction in October 1978 at the Sotheby Parke Bernet Galleries in New York.

#### SCOPE AND CONTENT NOTE

The William Paterson Papers, 1689-1841, primarily reflect the legal career of William Paterson (1745-1806), a prominent New Jersey attorney, senator, and governor who became an associate justice of the United States Supreme Court. More than half of the collection is taken up with files of court cases with which Paterson was involved. The remainder contains some documentation of the Paterson family, materials relating to East/West Jersey proprietors, a broad miscellaneous section, and a number of New Jersey court docket books.

The bulk of the papers focus on the cases in which Paterson was involved, from the time of his appointment as the first attorney general for New Jersey (1776) through his tenure as an associate justice of the Supreme Court (1806). The State and County Court Cases, 1765-1791, include cases which were tried before the New Jersey Supreme Court as well as the courts of Oyer and Terminer, Assizes, Pleas, and Chancery in the countries of Essex, Somerset, Morris, Monmouth, Middlesex, and Hunterdon. Federal Court Cases, 1793-1803, include those in which Paterson was involved while on the United States Supreme Court, a well as cases brought before the circuit courts of Delaware, Pennsylvania, Georgia, New York, and Rhode Island. The latter cover a wide variety of issues from simple debt or trespass to grand larceny, high treason, and murder.

This collection contains none of Paterson's personal papers. However, some of his business correspondence together with various fragmentary legal notes for the years 1780-1805 may be found in the Paterson Family series. Also included are miscellaneous documents pertaining to other family members: Andrew Bell, William's brother-in-law from his first marriage to Cornelia; Richard Paterson, William's father; Euphemia, William's second wife; and William Bell Paterson, William's son by his first marriage.

The East/West Jersey Proprietors and Miscellaneous materials do not pertain as directly to the Paterson family as the first two series. The former includes surveys' certificates and legal documents of various land transactions. The latter includes a variety of materials dating from 1756-1805 which deal with the City of Perth Amboy, maritime trade and law. There are also a number of case files and personal papers which cannot be readily attributed to any member of the Paterson family during this period. By contrast, the Court Docket books for the counties of Somerset, Middlesex and Hunterdon (1782-1787) and the New Jersey Supreme Court (1781-1807) contain comprehensive record of many cases which were tried during the most active period in Paterson's career.

#### SERIES DESCRIPTITION

These files are arranged chronologically by date. Case notes, by far the most common type of document, precede all other papers in each case.
