MEETING OF THE BOARD OF TRUSTEES OF THE WILLIAM PATERSON UNIVERSITY OF NEW JERSEY

Saturday, September 25, 2010

The meeting was called to order at approximately 9:05 a.m. in the College Hall Board Room.

ANNOUNCEMENT CONCERNING ADEQUATE NOTICE OF MEETING:

In accordance with the "Open Public Meetings Act," the Chairperson publicly announced and had entered into the minutes that "adequate notice" of this meeting was provided. In compliance with the Statute, this notice was posted on the University's web page and distributed to The Record, and The Star Ledger more than 48 hours prior to this meeting.

It was moved and seconded to adopt the following resolution:

At approximately 11:10 a.m., the Public Session resumed.

NOMINATIONS AND GOVERNANCE COMMITTEE AFFIRMATION OF OFFICERS 2010-2011

On behalf of the Nominations and Governance Committee, Mr. Taylor reported that state statute requires that the Board organize annually at its first meeting in September. He remarked that the role of the Committee for the last 145 years centered on nominating a slate of officers. About ten years ago, consistent with the on-going move towards autonomy, the charter of the Committee was updated to include the duties of governance, including but not limited to, identifying prospective candidates for the Board, providing a comprehensive orientation for new board members, and on-going board operations.

It was moved and seconded to adopt the following resolution:

The resolution was unanimously adopted.

MINUTES OF THE JUNE 26, 2010 BOARD MEETING:

The minutes of the June 26, 2010 Board were approved unanimously.

CHAIRS REPORT:

Mr. Mazzola welcomed President Kathleen Waldron and congratulated her on completing her first 55 days as President. He reported that the University has scheduled President Waldron's investiture ceremony for Friday, November 12 at 10:00 a.m.

Mr. Mazzola welcomed back student trustee, Melissa Zolla, who is now the voting student trustee. Student elections will be held shortly and a new non-voting student will be appointed to the Board.

Mr. Mazzola spoke about legislation that went into effect August, 2010 regarding the structure and fiscal management of higher education in New Jersey. Part of the legislation, known as the Lesniak bill, addresses structure and function of governing boards. The William Paterson University Board committees were already in compliance with the responsibilities legislated. Committees were restructured and renamed to more easily identify them with the functions they are required to fulfill. The composition of the Executive Committee must include the Board Chair, Vice-Chair, and each standing Committee chair. The restructured committees are: Personnel and Compensation, chaired by Dr. Henry Pruitt; Nominations and Governance, chaired by Mr. Robert Taylor; Finance, Audit, and Institutional Development, chaired by Ms. Linda Niro; and Educational Policy and Student Development, chaired by Mr. Will Pesce. Mr. Mazzola named the faculty senate liaisons to each committee: Professor Kathleen Korgen for Educational Policy and Student Development with Professor Tricia Snyder as alternate and Professor Sue Godar for Finance, Audit, & Institutional Development with Professor William Duffy as alternate.

PRESIDENT'S REPORT:

President Waldron thanked everyone for their support and warm welcome to the University. Dr. Waldron welcomed the newly tenured faculty to the meeting, congratulated them on their achievements, and read each of their names. She also welcomed the newly promoted faculty by name and promotional status. The faculty were acknowledged with a round of applause.

President Waldron reported on her first eight weeks, which included a trip to meet potential donors and alumni in California. She returned just in time to welcome the President of the Dominican Republic, Dr. Leonel Fernández Reyna and his wife to campus. President Fernández, a friend of the United States and a supporter of education, spoke to an audience of over 600. The visit culminated in the signing of an agreement of cooperation between the Foundation for Global Democracy and William Paterson University.

WPU hosted a delegation from Zhejiang University of Technology, an important regional university that educates over 30,000 students in the Hangzhou Province. The collaboration dates back to 2004 when a number of William Paterson students went to ZJUT on an exchange program. In 2007 ZJUT started sending students to WPU, and to date over 500 Chinese students have studied on campus in short term, specialized programs concentrated in the Cotsakos College of Business. The University signed a sister university strategic agreement of cooperation which promises to enhance and expand our collaboration to other disciplines. Representatives from the Chinese Consulate in New York were present for the ceremony as were numerous members of the press.

President Waldron reported on several important initiatives including the national search for a Vice President for Enrollment Management, preparation for the Middle States Accreditation decennial review, and a proposed plan to revise the budgeting process on campus making it more transparent and participatory by the University community. An off campus, indoor venue has been selected for commencement scheduled for May 18, 2011 at the Izod Center, East

Rutherford. An Honorary Degree Committee of faculty and staff has been formed to recommend persons to be honored with the award of an honorary degree, the University's highest honor.

COMMITTEE REPORTS:

NOMINATIONS AND GOVERNANCE COMMITTEE:

Mr. Taylor provided background on the history of the evolution of the Nominating Committee to the present Nominations and Governance Committee. From 1966 – 1986 the Board of Higher Education and the Chancellor of Higher Education had the responsibility for appointing board members to the nine state colleges with endorsement by the Governor. The Board of Higher Education had a committee that assessed prospective candidates. The individual college and university boards had no involvement in the selection or nomination of trustees. In 1986 new legislation gave colleges and universities autonomy in the areas of budget, buildings, faculty, and programs. In 1994 Governor Whitman abolished the Board of Higher Education and the Chancellor's office. The responsibility for appointment of trustees was given to the Governor with ratification by the Senate. The legislation also specified that each board of the nine state colleges and universities could present names to the Governor for consideration for nomination. The degree to which the Governor acted on the names presented by the individual boards has varied from governor to governor. The Nominations and Governance Committee has expanded its role from just nominating a slate of officers, to broader responsibilities incorporating the charges given in the Lesniak bill regarding governance of the institution.

PERSONNEL COMMITTEE:

The Committee reviewed a number of reports including the projected FY11 revenues and expenses and noted that the budget is on track. Preliminary fall enrollments were reviewed, the FY12 capital budget request was reviewed and bid waivers for the Global Financial Services Institute, Urban Enterprise Zone Grant, Institute of Museum and Library Services National Leadership Grant, Reforms II Math and Science Partnership Grant, Library Vale Consortium, and Institutional Advancement were reviewed and recommended for approval. EDUCATIONAL POLICY AND STUDENT DEVELOPMENT COMMITTEE:

Mr. Pesce reported that the Educational Policy and Student Development Committee met on September 10, 2010 and received a positive enrollment update on regular admit students, transfers, readmits and second degree students. The composite SAT scores for regular admit students increased. Graduate enrollment for fall 2010 has declined from the prior year, but this may be attributed to the widespread uncertainty of many teachers regarding their positions and tuition reimbursement programs. Graduate program development was reviewed as it relates to the Academic Plan and particularly curriculum development activities. Also discussed were the results of the non-returning student survey and efforts to provide additional programs. The results of the NSSE survey of student engagement were also discussed. End of the year highlights were received from Student Development including focus on student retention.
